

## **Introduce your Idol Promo**

### **Competition Terms and Conditions**

5. The winner of the Introduce your Idol Promo will win: A backstage tour. The chance to introduce an artist on the West Coast Blues 'n' Roots line up (the winner will choose one of five artists provided by Sunset Events).
